Statement of Proposed Pool Member:

I hereby acknowledge receipt of and agree to be bound by the Bylaws, and the Rules and Regulations of Hiwan Golf Club ("Club") as set forth by the Board of Directors and as may be amended from time to time. I understand that the duration of this membership is while the pool is open in 2018, approximately Memorial Day to Labor Day. This membership is a revocable licence, which is non-equity, non-participatory, non-transferable and terminable at will by the Board of Directors without refund of any fees. Membership does not imply any right or privilege to participate in or to administer the Club's business policies and does not create any vested, proprietary, prescriptive, or easement rights or interests in the Club or any Club asset. I understand this membership is for use of the pool only and any use of any other club facilities, e.g. the golf course, tennis courts, main clubhouse, is not permitted under this membership. Any attempt to use these facilities, except as a guest of another member, could result in termination. I also acknowledge that a \$250 food spending minimum at the pool snack bar is required during the term of the membership, and any unused minimum will be charged at the conclusion of the membership. This membership does not include clubhouse dining privileges.

At the expiration of this membership, I may elect to apply for membership in another membership category, which will be reviewed by the Board of Directors. Prior membership as a pool member is no assurance of acceptance as a club member in another membership category. Pool membership eligibility is for one year and re-application in future years is not permitted.

I hereby authorize the Club to charge the above referenced credit/debit card for all charges and purchases made by me or members of my family.

I understand that there may be times when the club facilities are closed to members for special events and tournaments at the discretion of the Board of Directors, and therefore, I accept the fact that the club's facilities may not always be available for use by me or other members of the club.

In consideration of the Hiwan Golf Club Board of Directors considering this proposal, my spouse and I authorize the club to conduct a background check to assess eligibility for membership. Since credit is being extended, my spouse and I also authorize the club to conduct a credit investigation. We authorize all persons who have information relevant to this application to disclose it to the Board or its agents. We waive any and all rights we, or either of us, may have to obtain from the club any such information disclosed to the club or its agents, and release all persons who furnish the club such information from any liability as a result of such disclosures. We understand that the investigation may, without limitation, include verification of all information contained in this proposal, and may also include criminal records, references, and statements from club members. Furthermore, we understand that all communications between the club and others, including its members, which are made for the purpose of this investigation, will be maintained by the club as confidential and privileged.
